Chair & Vice-Chair attended a tour Lions Gate Community centre with MLAs Kirkpatrick and Falcon and were given a chance to share more on libraries and to hear from other community organizations that attended. - 3.2 Director's Report For Truth & Reconciliation Day, the North Shore libraries ran an evening with Squamish Elder Sam George and Chief Janice George at Lynn Valley, a deeply meaningful event listening to the

5. BOARD MOTIONS/DISCUSSIONS

5.1 Policy Review – Elio Iorio (EI) – Manager, Financial Services, DNV gave an overview of each policy and the updates. A review is done to ensure the policies remain current. Amendments to B-FIN-2 & B-FIN-10 were housekeeping in nature and the amendments for B-FIN-14 provide improved clarification to better explain equipment lease standards and the process of considering a lease arrangement. Query from trustee about whether B-FIN-14 Equipment Leases includes leases of vehicles. El confirmed correct. Query from trustee about insurance coverage.

- 5.2 Community Engagement Survey Results The Library Director introduced Meghan Crowe (MC), Communications/Events Coordinator who shared a presentation on the summary of the results. Outreach to both users and non-users. Physical materials are still our core work and our library ranks number two in the province for circulations per capita, next to Greater Victoria Public Library. Results show lots of praise and compliments for staff with a few specific suggestions. Interestingly, users who visit frequently gave higher scores than less-frequent library users. Potentially up to 25% of users are using the library more since going fines-free, data which supports reducing barriers for our community. Query from trustee about the 29% of users who selected 'don't use our library because too far from home' if there is data to link what postal code those respondents are from. This would allow the Board to see where library services could be used in the future. Query from trustee of how this survey compares to previous survey data. MC responded that in terms of participants, we had an unprecedented response 3x previous surveys. While working with the data analyst, we learned about the potential for increasing clarity in data, assumptions and better questions to ask in future surveys. Presentation to Council may include some of the results from the data. Short discussion around the Strategic Planning workshop and utilizing this data to support the development.
- Indigenous Collections Strategy Krista Scanlon, Manager Collections Services, presented the Indigenous Collections Strategy. Foundational documents and plans that supported the development of this strategy; United Nations Declaration on the Rights of Indigenous Peoples, Truth & Reconciliation Commission of Canada Calls to Action, Declaration on the Rights of Indigenous Peoples Act Action Plan and the District of North Vancouver & səlilwəta?†/Selilwitulh (Tsleil-Waututh) Relationship Protocol Agreement. KS reviewed historical ways that libraries have categorized First Nations materials. Learning from authentic Indigenous voices. 'Walking in Good Relations' board game available at each branch, which challenges your assumptions and supports learning and unlearning for Truth & Reconciliation. Query from Trustee if it is known if local Indigenous people use our library. Director shared that səlilwəta?†/Selilwitulh (Tsleil-Waututh) school has a strong relationship with Parkgate Library, using it regularly. Building relationships, stakes a long time to change the perception of libraries, this work is multi-generational work and the strategy shows NVDPL's commitment to this. Various ideas and experiences were discussed around Reconciliation and the work going forward with not only the Indigenous collection strategy but how the organization continues with learning and unlearning as an act of Reconciliation.
